Objectives

At the completion of the course the student will:

1. Have gained an understanding of theatrical make-up.
2. Experience the practical application of make-up
3. Designed and executed a variety of make-ups.

Evaluation

This is an online class, as such you will need access to a camera and an internet connection, you will be assigned a series of make-ups, there will be a tutorial and then you will submit photos of your finished products. You will need to create an electronic portfolio.

Your portfolio will account for 40% of the grade

Practical make-ups will count for 60% of the final grade
